Re: Autograph America / Brian Burkel

Dear Mr. Creel:

You have already been sent a complaint. You obviously realize your exposure and this apparently had some effect in motivating you to remove *some* of the defamatory and libelous material off your web sites (as well as your poorly thought out cross-promotion with Mr. Frost and P.A.A.S.).

However, as you well know, defamatory material, with absolutely no basis in the truth *still* exists on your ISP server. Specifically, I refer the falsehoods at this URL address <http://allreaders.net/allscams/fakeautographsscaml.html>. This URL address is easily discoverable via commonly used words on search engines and, thus, is accessible by anyone with an internet connection. The law would consider this dissemination and publication.

The accessibility of these falsehoods to the general public damages Autographs Americas' business and continues to lead to lost sales. As you know, Autograph America is holding you personally and severably liable for all lost sales regardless of who you are acting in concert with.

**Thus, again, I demand that you cease and desist publishing any information about Autographs America, American Authentication Services as well as Brian Burkel and his family on Allreaders.net and Allscams.us and remove *all references* of the aforementioned immediately and without delay.**



On other occasions, you feigned that you do not know how to remove this information from your server.
