On or around June/july 2005 Michael W. Creel (Creel) DOB 5-1-1965, worked as loan officer for Solutions Financial with offices in Bellevue and Tukwila. I, Yves "Julian" Cauvin jr, was vice president and partner. During that time, Me. Creel got his real estate license.

I hired Mr. Creel to list one of my homes located in Bellevue, WA. After 1-2 months, I notice items and money was missing in my home. (Mr. Creel had key in order to show home and therefore was able to enter unattended) At the time, Mr. Creel and myself occasionally would have dinner, drinks or hang out with his wife and my girlfriend Carmen Arruda. One evening, while sitting in Mr. Creels car, I noticed my missing gold bracelet in the ash tray. A few days later, I fired Mr. Creel. He was upset and made threats he would "ruin" me or that he would "kill me" anytime he wanted. I took little notice to his threats as he drank heavily and did cocaine often. (I admit, I did cocaine at the time, that is how he has unauthorized picture of me/ He took this without my consent or knowledge) I am grateful to say I have not used in over 12 years and have been active in helping others stay clean and sober.

Sometimes between June and September 2006, my homes and cars were getting vandalized and burglarized. I called police on 2 occasions and police reports were taken. I could have called more times because several cars of mine had gotten flat tires from being stab and lug nuts loosened, whereas, my tire would have fallen off while driving.

Forensic police were able to extract fingerprints off of half glass of Vodka, I remember police officer making joke the burglar was making himself at home while having drinks. (It was discovered Mr. Creel was burglar as his fingerprint was "direct hit". At that time, it was close to 1 year since I spoke to Mr Creel. Initially, Mr Creel denied being taking my things as stated in his phone conversation with detectives. However, his accomplice, Marcia Smith (initially Ms. Smith replied "I do not want to say" but after a couple days, she admitted burglarizing home on several occasions. They entered by breaking into garage door then, Mr. Creel kicked in door entering house from garage. She testified he had some of my stolen property. (See Police Reports)

*Ms. Smith said when she entered the home the few times with Mr. Creel, "house was immaculate' But on the last occasion, it was "ransacked and vandalized" She never mentioned large bolder rock that was used by Mr. Creel on another occasion (He entered home on several occasions by himself)

Eventually, it was discovered Mr. Creel was using his notary license to create fraudulent documents. One included "Durable Power of Attorney" whereas, document stated I gave my prior assistant access to my bank accounts, safe deposit boxes and permissions to sell my real estate and other assets. Mr. Creel also used notary license that placed \$150,000 lien on my home for Mortgage Services and Bookkeeping. Mr. Creel fraudulently list me as signing "Durable Power of Attorney", I was unaware of this document. I was in California or Nevada on the date he list, plus by time it had about 1 and ½ years since I talked with him. I filed complaint with Real Estate Division and Notary Division in Olympia. (I was told it was very unlikely Mr. Creel could ever get his license again.) letters will be produced.

Because Mr. Creel was reported to police and officials. He was very upset and would leave messages he would "kill me" and "ruin me" (I have emails) He also, stated very elaborate lies. *This will be shown at hearing" Part of Mr. Creel efforts to ruin me was by stalking me online (he was hiding overseas) He was able to stalk me because he had all my information from the burglaries.

Many of the stories he would claim is I "conned women" or I stole \$80,000 from Marcia Smith. Ms. Smith and I were business partners in a flip. I would buy homes, remodel then flip for profit. (I had done several time successfully and had different partners on different homes.) This particular home was purchased right before the housing crises, where homes eventually lost 50% of their value, this home was eventually sold at \$70,000. We purchased for approximately \$500,000. *Mr. Creel was the realtor on this "short sale" and made commission. However, Mr. Creel and Marcia Smith claimed I conned her. The concocted story in order to give alibi for the burglaries and fraudulent document's. This was part of his "payback" to me for reporting fraud. (This was before they pulled his licensed)

As the police were closing in, Mr. Creel left the country and moved to Iraq to avoid prosecution. He was aware of the statute of limitations of the Fraud and Forgery. Mr. Creel did this fraud on several people. *All documents filed in King County Courthouse"

This is one of many lies Mr. Creel has told of myself, family and friends.

Mr. Creel has no moral judgement. Mr. Creel harassed war veteran of 15 years who suffers severe PTSD, my brother Patrick, he tried to commit suicide by burning himself inside home. Patrick was working at Microsoft at the time. However, he still suffered PTSD from doing 2 tours in the Middle East.

Mr. Creel knew about the suicide event, including the part, thank goodness of his leaving the house and going straight to a payphone to call police and report the fire. (He lost everything in fire, car, clothes etc) He did not hide, run or plead not guilty. He should have been sent to hospital not prison. Nonetheless, Mr. Creel posted numerous articles calling him "Arsonist" etc. I have emails Mr. Creel mocking me about this..

He has sent me threatening emails saying "how's that boy of yours" "How's your daughter" with pictures of my children included, (evidence will be provided at hearing). He also wrote 'Your sons going to hate you and you will never have any relationship with him, once I let his girlfriend, family and coworker "who his daddy is" I will post his picture (my son) and pay to have it promoted' (*I have copies of emails)

My father, son and myself all had Yves Cauvin as our name, this is a very unusual name and it was supposed to be something we hoped to carry on. Unfortunately, the amount of misinformation, slander and threats. It has caused tremendous pain and suffering to my family.

#1 My father committed Suicide in 2018 because of the embarrassment and shame (He graduated UW with degree in Civil and Electrical Engineer.

#2. My brother has tried committing suicide several more times. Mr. Creels posting his pictures with caption "Arsonist" He knows this is embarrassing and with social media relevance in life, he knows it can "ruin" people. Mr. Creel has no regard of him being clinically disabled. Patrick also suffers Severe Anxiety and has treatment 2-3 times a week. (I will provide letter from doctors with his diagnosis at hearing)

#3. My ex-wife is Kim Brooke, president and owner of Modeling Agency Kim Brooke Group located in Seattle. Mr. Creel befriended her, and pretended to be interested in her agency. She modeled throughout the United states and Europe. I was also, in band and group. Kim and myself have

experienced groupies and people who get obsessed. While my wife modeled or when my group performed we would need security from certain people. Mr. Creel has these traits police told us about.

#4. Because of the unflattering negative information (many lies, unsubstantiated or created by Creel) caused my son to change his name. Mr. Creel sent me email stating "Your son had to change his name because the information)

#5. Last year I legally changed my name (Grant County) for several reason, Mr. Creel posted my driver's license and SS number on the internet. (Mr Creel was setting up emails in my name AND even registered domain "Julian Cauvin". I was also subject to identity theft, Mr. Creel would stalk me online and send letters and messages to employers and business associates, (I have email from him bragging about doing this) Mr. Creel sent letters to my neighbor with derogatory information and lies and has pretending being customer and saying I did something inappropriate or that I was going to steal peoples Id because I was "conman". Mr. Creel knows I have made hundreds of thousands, I was vice president of Mortgage Company, never was I accused of taking someone ID. However, the lies and harassments usually becomes to much "Drama" for any company to deal with. BUT, 3 months ago, I get email from Mr. Creel saying he knows of my name change and sends "check out my new information" He discovered new name and hacked my facebook account and got it flagged, stating, I was running business without license. He also said he was contacting FBI.

(MR. Creel does not know anything about business. Each person is allowed to sell 5 cars in their name each year without license, a married couple could do 10, if a person has 5 partners 30 could be sold, Also, my business model included repairs, therefore, many clients would ask if I could help sell their home. I would offer this as courtesy for FREE. However, Mr. Creel contacted facebook and ebay and had my account shut down. Mr. Creel send mocking emails bragging about what he's doing. For the record, when a person applies for dealer's license, one of the requirements are having a business location prior to getting license. Usually take 6 months. (Basically you are paying 6 months' rent without being able to run full dealership)

Another way Mr. Creel harasses me is by sending email, pretending to be customer, he wants to buy and then have me meet him and wait for hours and he would never show up. He would have friend call or just end email and text, to make difficult to trace. All the weird things started happening 3 months ago.

The recent acts of my business, home and cars being vandalized and broken into, I have 3 reports with the Moses Lake and Ephrata Police department. One of the latest incidences is someone loosened all my bolts to hold tire on the driver's side on my car, therefore if I would of traveled fast on freeway, tires falls off and people get killed. Driver and other innocent people. My car was also keyed. 2 off my cars mysteriously stopped working and my 3rd had the wheel bolts loosened. Last week I observed Mr. Creel or someone with his same appearance (Bald, white complexion with another man). This happened this past week, same times problems with cars? Coincidence?

His efforts to "ruin me" included calling me "Con Man" "Don't do business with Julian" etc. is solely to harass and interfere with my life and family.

Mr. Creel is 56-year-old man who follows another man's life is not normal. My family and friend fears for me and themselves as Mr. creel is unpredictable.

Washington State Anti-Harassment definition:

What is "unlawful harassment?"

A knowing and willful "course of conduct" directed at you which seriously:

- Alarms you;
- Annoys you; or
- Harasses you; and
- Serves no "legitimate or lawful" purpose;
- Would cause a reasonable person to suffer substantial emotional distress, and actually causes substantial emotional distress to you.

What is a "course of conduct?"

- A series of acts
- Over a period of time (however short)
- With an on-going purpose

This fits exactly what Mr. Creel has been doing. His history of committing burglaries, identity theft, vandalism, and his ongoing efforts prove he is unstable. I have witnessed him abuse alcohol and drugs.

His obsession is part retaliation, hate, jealousy and the fact he enjoys harassing and bullying people I

on her deck. She said that she had obtained the chair after an associate; Eric Westfall had left the chair at her Newport Hills home, which he rented for a short period. I told her that I needed to collect the chair and she agreed. She also said that Michael Creel had two other patio chairs.

As I continued to speak with Smith she made the statement "I will tell you the full truth." I did take the two chairs from the back deck in August." I asked if she had gone into the house and she said "I can't tell you that." She also admitted "I have a white leather chair and ottoman that came from the house on 119th." "I only really wanted the paperwork."

2007 hours I called Creel at his home. He stated that he had recently sold Smith's condominium for her. I asked him what he knew about Cauvin and his property. He said that a month ago Smith called him and said that she had seen Cauvin and his girlfriend at Cauvin's home on 119th AVE SE. Smith also told him that traffic flaggers near Cauvin's home had told her that they had seen someone stealing things from the house.

Creel said that he was last in the house around January, after Cauvin was released from jail. He denied having anything from Cauvin's house stating that his house was beautifully furnished and he would not need anything from Cauvin.

2030 hours I disconnected the call and by the time I could call Smith her phone number was busy.

2032 I was able to reach Smith and she said that Creel had just called but she had told him she could not speak. She admitted that Creel had a rocking chair, an outdoor grill some Asian art, sheets and a duvet cover from Cauvin's home. She admitted that she had gone into the home on two occasions and took the property.

2140 hours I went to Smith's home and at that time I advised her of her rights which she stated that she understood. She admitted that she had entered Cauvin's home multiple times and stole items from the home. She admitted that she had stolen the deck chairs and grill from the back deck of the home in July, 2006 and that she had taken the items to Creels home because he had been so helpful to her regarding Cauvin and the sale of the home. She made the comment that she would have taken the patio table but it was too heavy to carry.

The first time she said that she entered the home when Creel "popped" the side door of the garage. She said that she was nervous so she waited in the garage and Creel went inside the home, but he said that "everything was immaculate." She did not know if Creel stole anything from the home the first time.

Smith said that she and Creel returned a few days later and everything had been ransacked. She said that it was during this time that Creel drank the vodka and used the glass where his fingerprints were recovered by Officer Wolff. It was this time that Smith says that Creel stole the sheets and duvet cover. She also said that Creel was in possession of a DVD/VCR machine,

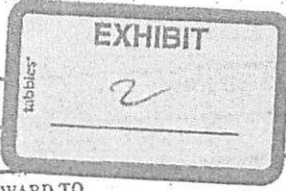

Summary: Suspects entered Cauvin's home on multiple occasions and stole several pieces of furniture. Both suspects confessed to entering the home and taking several of the listed stolen items, which I recovered from their homes.

Narrative: The following occurred in the State of Washington, County of King, City of Bellevue at the home of Yves Julian Cauvin which is located at 4460 119 AVE SE.

09-12-06 Bellevue Police Officer M. Wolff initiated Bellevue case number 06-10580 to document the burglary of the Cauvin's home. Cauvin was reportedly in CA at the time of the report so the crime was reported by Cauvin's associate Sky Benson. Benson was at the home on 08-30-06 and he saw no signs of a burglary. On 09-12-06 he went inside the home and found that it had been ransacked. Officer Wolff spoke with Cauvin briefly, by phone but she could get a definitive list of what had been stolen from the home. Benson provided a tentative list based on his memory of the furnishings.

Based on Officer Wolff's and Benson's observations it appeared that the suspect(s) had forcibly entered the home by prying the interior door leading from the garage to the house. Benson also advised that the gate had been forced open. Benson and Wolff also noted damage to the interior alarm box and the railing of the stair way had been shoved upwards.

In the kitchen, Wolf processed a glass mug which Benson indicated had not been on the counter the last time that he was in the home.

10-04-06 Bellevue Police Forensic Specialist C. Nicoll examined the print that Office Wolff recovered from the mug and he then entered the print into AFIS. The system identified Michael Creel as a possible suspect. Nicoll made a direct comparison of the recovered print to Creel's fingerprints and determined that the print was positively that of Creel's left middle finger. COPY OF EVIDENCE IN POLICE REPORT

10-06-06 Officer Wolff returned to Cauvin's home to investigate a second burglary of the home, the facts are documented under case 06-11591. Cauvin returned to his home and found that it had been burglarized again. This time the suspect(s) threw a rock through a bedroom window to gain entry into the home. Cauvin said that he had been at the home on 10-04-06 and that the burglary had occurred after that visit.

Cauvin advised that he believed that "two ex-business partners" had possibly been involved in the burglary. Cauvin and his girlfriend Jill Morganpage also advised that they had been to Marcia Smith's (business associate) condominium and they had seen one of the stolen chairs on the back deck of the unit.

10-10-06 1357 hours I spoke with Cauvin over the phone. He advised that Michael Creel was a previous business associate who was last in the house over a year ago. He said that there was no reason that Creel's fingerprint would still be on the mug. He also said that Creel and Marsha Smith are friends. He again mentioned that he had been to Smith's condominium and he had seen one of his stolen patio chairs on her rear deck. Cauvin mentioned a third individual, Ron Belec who was associated with Smith and Creel. Cauvin said that Belec had illegally seized his Porsche and he was meeting Det Merrick regarding the Porsche. Cauvin said that his girlfriend, Morganpage had also reported a burglary of her home to KC Sheriff's Office regarding Belec and the Porsche.

Dear sirs,

My name is Julian James and I am the owner of images of pictures including picture on ebook "How to Make Money Buying and Selling RV's and Motorhomes". A website that your company hosts (according to WHOIS information) is infringing on at least one copyright owned b.
