IMPORTANT:

- 1) If the person named in the warrant is **not in custody**, deliver a copy of this form to the Sheriff's Office **immediately** to prevent the person from being arrested.
 - a) If in the **King County Courthouse**, take this to **Room W-150**.
 - b) If in the **Regional Justice Center**, take this to **Room 1B**.
- 2) If this is a **Family Law contempt** case, call the person listed in the Order for Warrant (call the attorney if one is listed) by 9 a.m. on the next business day to confirm your next court appearance and avoid another warrant being issued for your arrest. Return-on-warrant hearings in family law cases are heard at 1:30 p.m. in room W-291 of the King County Courthouse (for SEA cases) or room 1G of the Regional Justice Center (for KNT cases).
- 3) The bail may be exonerated and returned only upon court order. You or an attorney must prepare the order and present it to the court. If you are the bail payer, your name must be indicated on the order as the recipient of the bail money. The court may order court costs or fees to be paid from bail proceeds. In contempt cases, the court may decide to apply the bail to child support or court imposed sanctions, even if bail was paid by someone other than the person in custody. A \$10.00 Trust Account Service fee will be deducted from the bail amount upon return.
